



**CUPE LOCAL 5430 Scholarships**  
***Policy # 21 – Alistair Mackenzie Scholarship Fund***

CUPE Local 5430 has set up criteria for five (5) scholarships of \$500.00 each for CUPE Member(s) or a dependent (as determined by Revenue Canada) of a CUPE Member

Criteria for \$500.00 Scholarship:

1. That applicant(s) shall be a CUPE Member or a dependent (as determined by Revenue Canada) of a CUPE Member
2. a) That the applicant(s) shall be enrolled in an accredited school/university of which tuition is charged to the student.  
b) That the applicant(s) shall be enrolled and completed the course between January 1 and December 31 of the year the scholarship calendar year.
3. CUPE Member(s) or dependent(s) are eligible for up to one (1) scholarship annually.
4. a) First preference given to applicant(s) that have not been awarded a scholarship previously  
b) The Regional Executive shall review and determine the successful applicant(s) no later than March 15 annually.
5. That the applicant(s) will submit a five hundred (500) word essay/brief to the CUPE Local 5430 Region Office no later than February 28 of each year.

The topic of the essay – “ Why is privatization bad for Saskatchewan and its peoples?” Essay/briefs will be stamped and dated.
